US to slap visa ban on errant foreign officials

Agencies WASHINGTON

The U.S. will impose visa bans on foreign nationals it deems to be censoring Americans...

Rubio did not name any specific instances of censorship. But U.S. tech companies and the Trump administration have challenged U.S. allies in Europe...

Rubio said in a statement that a new visa restriction policy would apply to foreign nationals responsible for censorship of protected expression in the U.S.

"It is similarly unacceptable for foreign officials to demand that American tech platforms adopt global content moderation policies or engage in censorship activity that reaches beyond their authority and into the United States," Rubio said.

Some foreign officials have taken "flagrant censorship actions against U.S. tech companies and U.S. citizens and residents when they have no authority to do so," Rubio said.

The Trump-appointed chairman of the U.S. Federal Communications Commission in March warned the EU Digital Services Act excessively restricts freedom of expression.
